# Report to the parish council 5/7/2025 Cllr Jill Haynes Chalk Valleys Ward

Dear Clerks, councillors and members of the public please find below my report for May and June 2025.

#### Booking system introduced to visit the tip

The hot topic at the council at the moment is the imposition of needing to book a time slot to visit the Household Recycling Centres (the tip). Many people are very concerned that they were not consulted on the change and that this will reduce their choice of time and day to visit the tip. However, after a lot of protest against the proposals there has been a U turn and these will now be introduced at four HRC and not across the board. The HRC's are Dorchester, Wimborne, Sherborne and Shaftesbury. The matter will be debated further at the full council meeting next week with a motion to council to ensure there is public consultation on the changes. The new system was introduced for two reasons, firstly at some HRC's there can be a long queue to get onto the site causing congestion and inconvenience to others, secondly the changes will make savings for the council of £100k.

#### Local plan update

The Government has changed the housing allocation numbers and created a considerable challenge in finding additional new housing allocation sites. Our required numbers have increased from 1793 to 3246 needing to be built each year of the plan – nearly double!! We still have to comply with the timeframe of having the plan completed in 30 months. At the moment it looks like the duty to co-operate with other council areas is likely to go which is a bit of good news as this could have increased the numbers by 10K in the life of the plan. It is anticipated that the new plan and site allocation proposals will go out to consultation on 18<sup>th</sup> August 2025 for a period of 8 weeks. There will be a number of roadshows across the council area but dates are not confirmed yet – probably in September. A consultation on the new Minerals and Waste Local Plan will happen at the same time.

#### **Children's Services Ofsted is Outstanding**

Ofsted inspected the councils Children's Services between 10<sup>th</sup> and 21<sup>st</sup> March 2025. For those of you who are not often involved in this area an outstanding result is very exceptional and shows the council's children's services as one of the best in the country. The inspection was on the following areas:

Overall effectiveness - Outstanding

The impact of leaders on social work practice with children and families – Outstanding The experiences and progress of children who need help and protection – Outstanding The experiences of children in care – Outstanding

The experiences and progress of care leavers – Good

This is a fantastic report resulting from the commitment and hard work of our front-line staff and the dedication of their leadership team.

#### **Economic growth strategy**

The Cabinet approved a new economic growth strategy at the June meeting. Dorset has significant opportunities to secure inward investment through the realisation of a number of projects in three main areas. These are clean energy and storage, sovereign defence capabilities and regeneration of our areas of significant population. Providing a strategy focusing on these areas does provide confidence to central government when bids are placed for funding. Personally I did find the strategy lacking in support for rural areas. There is little or not mention of farming or agriculturally based businesses and seeming no support for our innovative small businesses which make up the bulk of job opportunities in

the very rural Chalk Valleys ward. I have raised these concerns and hope that the strategy will be "work in progress"

### High Risk of Fire from BBQ's and bonfires

We have had such a long dry spell that there is now a very high risk of fire in our woods and fields. While it is great to be outside and enjoying the weather please be aware that lighting a disposable barbeque or a fire in the open countryside is really dangerous at the moment. I realise that this probably doesn't apply to most Chalk Valley residents but if you see any visitors doing that could you politely point out the danger to them too. One spark and a bit of a breeze and a fire is quickly out of control.
